

Students enrolling in kindergarten through twelfth grade or early child programs, whose legal guardian is claiming an exemption to immunization for medical, religious, or personal reasons, must complete an online immunization education module at <u>immunize.utah.gov</u> or attend an in-person consultation at a local health department.

A copy of the exemption form must be presented to the school or childcare official, along with a statement signed by a licensed healthcare provider for medical exemption.

#### Terms

#### Terms of Service

I am using the Public Immunization Portal (PIP) to access my own personal information or information of another of which I am the legal parent or guardian, using my legal identity. I am not using PIP representing another person or using another person's information or identity, even if I have that person's written permission.

I understand that PIP and immunization records contain confidential information protected under Utah Code.

I consent to the monitoring and recording of my use of PIP, including any electronic communications (such as click-to-chat or messaging).

I understand that it is a crime to:

- Give false or misleading statements to obtain information in government records;
- Give false or misleading information to obtain or alter confidential records; or
  Deceive the State of Utah about an individual's identity.

I understand that unauthorized use of PIP is a misrepresentation of my identity to the state government and could subject me to criminal or civil penalties, or both.

I understand that the state of Utah may stop me from using PIP if it finds or suspects misuse.

I accept the responsibility to properly protect any information provided to me by the Utah Department of Health and Human Services, I am the responsible party should any information on or from my computer or other device be improperly disclosed.

- 12. On the "Immunization Exemption Introduction" screen, follow the steps below to enter exemption information for your child.
  - a. From the "Exemption Reason" drop-down menu, select the type of exemption: (Medical, Religious, or Personal). Only one exemption type can be selected.
  - b. From the "Exemptions" drop-down menu, select the vaccines you are choosing to exempt your child from. You can select individual vaccines or choose to exempt your child from all required vaccines.
  - c. Click "save" when you are finished, or "cancel" to exit without saving.
